IV. Business

- A. RICAS (RI Comprehensive Assessment System) overview
 - a. Overall, all Chariho scores were low but better than the state
 - b. Reasons for lower scores
 - i. COVID no experience with test in 2020 first time for both third and fourth grade
 - ii. COVID still had distance learners; different experience than those in the classroom
 - iii. Social Emotional needs were in the forefront for students in order to lessen anxiety of COVID and protocols needing to be followed
 - iv. Item analysis shows skills which had not been taught were tested on
 - v. Test was taken in March during morning and afternoon timesconcern over student quarantine from April vacation
 - c. Preparation for 2022 RICAS third and fourth grade
 - Front load and expose students to skills not yet taught
 - ii. Continue to use Math textbook and language with fidelity

B. ESSER III Funding

- a. Fourth stage of federal money (CARES Act, ESSER I, ESSER II)
- b. Previous funding put into purchase of PPE, HEPA filters, bussing

- c. Superintendent Picard and Mr. Draper explained what the funding is meant to do and the amounts given to the district
- d. A plan needs to be submitted to the state along with a process for tracking the allocation of funds
- e. Collaboration between Chariho and the state already happening regarding the use of the funding
- f. RICAS data being used to support implementation of new curriculum material in Math and ELA
